Genesis Lease Limited is a global commercial aircraft leasing company headquartered in Shannon, Ireland. The company was established in 2006 and currently owns 41 aircraft leased to 30 airline customers in 17 countries. We leverage the worldwide platform of GE Commercial Aviation Services to service our portfolio of leases, allowing our management team to focus on growing the business. Our primary focus is on modern, operationally efficient, jet aircraft with substantial operator bases and long remaining useful lives.

In December 2006, Genesis completed a \$640.8 million IPO, a \$79.4 million private placement and an \$810 million securitisation transaction to acquire our initial portfolio of 41 aircraft. For the quarter ended March 31, 2007, Genesis reported revenues of \$42.2 million and Net Income of \$11.0 million. In April 2007, Genesis completed a \$1 billion syndicated senior secured revolving credit facility to support the growth of the business and announced an agreement to purchase two new Airbus 320 aircraft as part of the company's exciting growth plans. In June, Genesis will move from its temporary home in Limerick to one of Ireland's most advanced business campuses – Westpark Shannon.
